- 1. Approval of Agenda: Motion by Trowbridge second by North to approve the agenda as presented. Motion carried, unanimous yes vote.
- 2. Public Input
 - a. Dan North would like to thank the election workers for working at the past election and he had talked with the clerk about getting more people involved and discussed talking to the local schools to see if any eligible students are interested in volunteering
- 3. Building Inspector Report
 - a. none
- 4. Approve Minutes of March 13, 2018 Regular Meeting: Motion by Nyhagen second by North to approve the minutes as presented. Motion carried, unanimous yes vote.
- 5. Approve Minutes of April 5, 2018 Special Meeting: Motion by Nyhgaen second by Plummer to approve the minutes as presented. Motion carried, unanimous yes vote.
- 6. Financial Report: Motion by North second by Trowbridge to approve the financial report as presented. Motion carried, unanimous yes vote.

- a. Award 2018 road project bids 29th Street Gravel, 29th Street Blacktop, Barron/Dunn Hill Cutting and Gravel
 - i. 29th Street Gravel: Motion by Hanson second by Nyhagen to accept the bid from Olynick at a price of \$9.88/yard for a total of \$16,746.60. Roll call vote Trowbridge Yes;
 Nyhagen Yes; North Yes; Plummer Yes; Hanson Yes. Motion carried.
 - ii. 29th Street Blacktop: Motion by Nyhagen second by Plummer to accept the bid from Monarch Paving at a cost of \$168,122.64 for blacktop and include the pulverizing for \$5,386.52. Roll call vote Trowbridge Yes; Nyhagen Yes; North Yes; Plummer Yes; Hanson Yes. Motion carried.
 - iii. Barron/Dunn hill cutting and gravel: the board discussed the completeness of the bid packets. Motion by Hanson second by Plummer to rebid the county line project. Motion carried, unanimous yes vote.

- b. Discussion and possible action on building ordinance and mobile home/camper ordinance
 - i. Consultant LaFond shares there are two ordinances buildings & mobile homes. The board discussed both ordinances and a few consistencies in the building ordinance. Motion by North second by Trowbridge to pass ordinance 2018-02 Building and Mobile Home conditioned on the receipt of the document from the consultant as discussed. Roll call vote Trowbridge Yes; Nyhagen Yes; North Yes; Plummer Yes; Hanson Yes. Motion carried.
- c. Discussion and possible action on mobile home/camper ordinance
 - i. Consultant LaFond reports this ordinance deals with recreational campers as a temporary dwelling. Motion by North second by Nyhagen to approve ordinance 2018-01
 Recreational Campers. Roll call vote Trowbridge Yes; Nyhagen Yes; North Yes;
 Plummer Yes; Hanson Yes. Motion carried.
- d. Discussion and possible action on designated funds resolution
 - i. Consultant LaFond shared some options with the board of what they could do with the sand company royalty payments. The board discussed the options. Consultant LaFond also reported he reached out to the Wisconsin Department of Revenue about reducing the tax levy for one year and supplementing the difference with royalty funds. The DOR said the town cannot do that. If we did, it would reduce future levy amounts.
 - ii. The board discussed Resolution 2018-02 approving paying off the town hall. Motion by North second by Nyhagen to approve resolution 2018-02. Roll call vote Trowbridge Yes; Nyhagen Yes; North Yes; Plummer Yes; Hanson Yes. Motion carried.
 - iii. The board discussed Resolution 2018-03 approving paying off the town truck. Motion by North second by Plummer to approve resolution 2018-03. Roll call vote Trowbridge Yes; Nyhagen Yes; North Yes; Plummer Yes; Hanson Yes. Motion carried.
 - iv. The board also discussed creating designated funds accounts for future expenditures.

 Motion by Nyhagen second by Trowbridge to support the creation of the designated funds accounts. Roll call vote Trowbridge Yes; Nyhagen Yes; North Yes; Plummer Yes; Hanson Yes. Motion carried.
- e. Public Nuisance Mailing update and landowner response
 - i. 4 Hwy SS the building is down but a pile of rubble still there. The board discussed next steps. Supervisor North suggested sending a letter to landowner thanking them for the progress and to inform the board when they feel they have complied with the ordinance. The board directed the clerk to do so.
- f. Discussion and possible action on extending Patrolman Harelstad's employment through December 2018: Patrolman Harelstad gave his notice of resignation today saying his last day of full time employment would be December 31, 2018. Motion by Trowbridge second by Nyhagen to keep Patrolman Harelstad on until December 31, 2018. Motion carried, unanimous yes vote.

- h. Royalty Audit discussion and action: The board discussed requesting to audit the sand companies shipping records to make sure they match with what we received for royalty payments. The board also reviewed payments received recently to ensure the sand companies had paid for their sand shipped. Consultant LaFond requested the board members to submit to him any questions to the sand companies regarding royalty payments and they would consider setting meetings with the sand companies.
